Rules and Regulations

'the studio - international film actors' training, inc.' will be hereafter referred to as 'THE STUDIO'

1. Acceptance

'THE STUDIO' will accept your application with a letter of confirmation if all requirements are fulfilled, e.g. receipt of your signed application form, resumé and deposit.

2. Payment

All fees are payable in U.S. funds (\$). A 10% deposit is required at the time of your application. Full payment must be received no later than three weeks before the first day of the workshop. If we have not received full payment on the day the workshop starts, the student can not participate at the workshop until full payment has been received. If we have not received full payment by the appropriate date your space will be offered to those on the waiting list. If your space can not be filled 'THE STUDIO' has the right to withdraw your acceptance and request refund costs as noted under No.4 (see below).

3. Fees and Services

'THE STUDIO' has the right to charge you for any special requests and services other than described in the program. Please see program and confirmation letter for a description of services included in the workshop fee. The participant is responsible for all bank fees. Changes of the program and replacements of the staff are possible at the discretion of 'THE STUDIO'.

4. Withdrawal and Refund Policy

Enrollment is limited. Your cancellation must be submitted to 'THE STUDIO' in writing.

a) If you must cancel the workshop, 'THE STUDIO' has the right to request appropriate compensation based on the following formula:

-in any case a non-refundable application fee of \$ 100 will apply. We will refund all other moneys

-prior to one month before the start of the workshop - 10% (90% refund)

-prior to 22 days before the start of the workshop - 45% (55% refund)

-prior to 15 days before the start of the workshop - 75% (25% refund)

-from 14th day before the start of the workshop - 100% (no refund)

b) No show is not regarded as cancellation. The student is required to pay the full fee.

5. Substitution

Instead of yourself you may propose a substitute student for the workshop. 'THE STUDIO' has the right to refuse a substitute if the person does not fulfill the necessary acceptance criteria (acting skills, knowledge of English etc.). A non-refundable administration fee of \$100 is required for substitution. A substitution always indicates a cancellation on part of the original participant.

6. Course Cancellation and Dismissal

a) if 'THE STUDIO' cancels a course we will refund all moneys paid, in full. We cannot be responsible for refunds of airline tickets, car rentals or any other charges related to the cancelled course.

b) The use of stimulants, depressants and/or other drugs while attending 'THE STUDIO', as well as a general lack of responsibility in attendance, or unprofessional behavior on 'THE STUDIO' grounds or any other location connected with the workshop, is reasonable cause for dismissal. No fees will be refunded in case of dismissal.

7. Limits of Liability

a) All Actors who sign up guarantee to be in perfect health and are fully and solely responsible for their health needs. 'THE STUDIO' does not provide medical services and is not responsible for any accidents, injuries and deaths.

b) 'THE STUDIO' is not responsible for any damages, accidents, injuries or deaths occurred through services of others including but not limited to air transportation, rental car companies, Oakwood accommodations, transfers to/from the airport, the acting studios of all coaches and the coaches.

c) General liability of 'THE STUDIO' is limited to damages occurred with intent or culpable negligence during 'THE STUDIO' activities.

d) General liability is limited to an amount equaling one time the workshop fee.

e) The student is fully and solely responsible for his transport to and from the workshop location, especially on-time arrival in Los Angeles and travels and transportation during his workshop stay in Los Angeles.

f) Health/Liability Insurance: It is recommended to get a travel-health and trip cancellation insurance for the duration of the trip. The student affirms that he/she has adequate health and/or other insurance to cover any injury or damage he/she may cause or suffer while participating in the workshop activities, or that he/she is financially able and agrees to bear the costs of such injury or damage to him/herself, property, or others.

7. Indemnification.

The student agrees to indemnify and defend 'THE STUDIO' workshops against and hold 'THE STUDIO' workshops harmless from any claims arising out of his participation in any of the 'THE STUDIO' workshops. The terms "indemnify" and "defend" mean that the student will defend and protect 'THE STUDIO' workshops by payment or reimbursement for any costs or expenses incurred by 'THE STUDIO' workshops. This indemnification includes reimbursing 'THE STUDIO' workshops for reasonable attorneys' fees and related costs of litigation, including discovery.

7. Additional Bookings for 'Intensive', 'Individual', 'Special' and 'Masterschool' Trainings have to be executed through and by 'THE STUDIO' and paid to 'THE STUDIO'.

8. The statute of limitation is 6 months.

9. Visa and Customs Regulations

A student visa is not required for attending the 'THE STUDIO'. The student is solely responsible to fulfill visa, customs and currency regulations.

10. Arbitration

Any dispute, claim or controversy arising out of this Agreement or any portion thereof shall be settled by binding arbitration pursuant to the rules of the American Film Marketing Association in Los Angeles, CA with each party bearing his own costs, expenses and attorney fees.

11. Jurisdiction

This Agreement is made and shall be interpreted pursuant to the laws of the State of California applicable to agreements which are executed and fully performed within said state.

Changes of any policies in this document must be made in writing.

12. If any of the foregoing policies are voided it will not affect the remaining part of the document.

13. 'THE STUDIO' is not responsible and liable for any damages, injuries, accidents, deaths caused by natural calamities including but not limited to earthquakes, mudslides, tornados, floods, tsunamis etc.

14. Nature of Release. This release, waiver, rules and regulations, and Indemnity Agreement is intended to be as broad and inclusive as permitted by the laws of the State of California. If any portion of the Agreement is held invalid, the remainder of the Agreement will still continue in full legal force and effect.
